## LEGISLATIVE UPDATE

This past summer WAHI was made aware, through a magazine article, that some new legislation might be coming down the pipeline regarding home inspections in the State of Wisconsin. We immediately contacted our lobbyist, Kathi Kilgore, to discover that nothing was *official* at the time and the vast majority of Representatives and Senators were not aware of any such legislation.

We reached out to the author of the article and scheduled a meeting with him and the group named in the article as part of the legislation. Since that meeting, countless hours have been spent to ensure our concerns were heard and that we were very much a part of the discussion that would affect the very people that we represent, home inspectors in the state of Wisconsin.

At the time of this writing, WAHI's concerns with portions of the legislation remain but negotiations with the bill sponsor and other trade associations continue. However, the legislation may be circulated for co-sponsorship among the members of the Legislature very soon. The State Legislature will wrap up its work for the two-year legislative session in February 2020.

A summary of the legislation as it is currently drafted:

- 1. **Licensing of Home Inspectors** At present time, home inspectors are a profession that requires **registration** with the Department of Safety and Professional Services (DSPS). This bill would require home inspectors to be **licensed**. All current home inspectors would be grandfathered in as licensed home inspectors. There is some concern with licensure vs. registration in how that could affect WAHI's continued ability to provide what WAHI has considered to be its strength: education to our members. The fine details of that would not be spelled out in the bill, but would be determined in the DSPS rule-making process that WAHI and its members would have input in.
- 2. **Pre-Licensing Education** Future home inspectors would be required to complete 120 hours of instruction and 40 hours of field training in addition to the current requirements for home inspector registration. Current home inspectors would not be subject to this requirement because they will automatically be considered "licensed." WAHI hopes this provision could prove to be an opportunity for WAHI to become involved in pre-licensure education and create a new revenue stream in doing so. However, the uncertainty of the "fine details", as stated above regarding continuing education, is the same here.
- 3. **Reciprocity** Inspectors from other states with comparable or more restrictive licensing requirements would be able to do inspections in Wisconsin and, likewise, Wisconsin-licensed home inspectors could do inspections in other states with comparable or less restrictive licensing requirements.
- 4. **Required used of the word "Defect"** Currently, home inspectors are not required to use the term "defect" in their home inspection reports. This legislation would require the use of the term "defect" when a condition aligns with the definition of Defect as defined in existing statute s. 440.97 (2m). This particular item has been the topic of many of the discussions and negotiations as WAHI takes strong issue with this section of the bill.
- Required use of a Summary Page The bill requires a summary page be included as part of the home inspection report with a specific order of information and references to the item or page number in the home inspection report. WAHI has indicated that we would be open to use of a summary page. However, WAHI leadership does <u>not</u> agree with the prescribed order, headings and reference requirement. We believe the design of the summary page should be left up to each individual home inspector and that a Buyer should be informed that the summary page is not to be used as a substitute for reading the entire report. We are open to suggested headings of subject matter but, not required to use those exact terms. We also have concerns with referring to parts of the home inspector report by item or page number and have requested more flexibility, such as referring to a heading or section of the report.

Again, this is a brief synopsis of the legislation and a reminder that we are STILL negotiating on the use of the word defect and the summary page. Because the bill draft hasn't been released yet, many of your Representatives and Senators don't even know this is out there yet. They will not become aware of it until the bill is circulated for co-sponsorship. Watch your email for an action alert from WAHI in the near future! We will provide information on how to contact your state legislators about this bill.

# TOP 5 GENERAL LIABILITY CLAIMS AGAINST HOME INSPECTORS

If you've followed our series on the top claims against home inspectors, you know that most industry allegations involve errors or omissions, which mean they are filed against inspectors' E&O coverage. (For those of you who've missed them, check our articles on the industry's top claims <a href="here">here</a>. We recommend starting with the <a href="Top 5 Claims">Top 5 Claims</a>.) However, like E&O claims, there are certain types of general liability (GL) claims that are more prevalent than others. We discuss the top 5 general liability claims against home inspectors and how you can avoid them.



#### What is general liability insurance?

Unlike errors and omissions (E&O) claims, general liability claims don't typically question the quality of your home inspection or service. Rather, GL claims involve any bodily injury or property damage that result from the inspection. (Learn more about the two coverage types and why they're important here.)

There are many reasons to carry general liability insurance coverage. In our survey of over 450 home inspectors, we found that the top three reasons inspectors choose to carry both E&O and general liability insurance are to:

- 1. **Avoid large payouts for claims.** According to <u>The Hartford</u>, a general liability claim can <u>average more than \$75,000 per case</u> to defend and settle when a lawsuit is involved.
- 2. **Receive claims handling and defense.** When you work with an insurance company familiar with the home inspection industry, their claims team can minimize or eliminate your potential liability by properly handling claims. In many cases, our claims team's industry knowledge enables them to resolve liability claims quickly, saving insured precious time and money.
- 3. **Fulfill licensing and state requirements.** As of September 2019, the following states have general liability requirements: Alabama, Arkansas, Florida, Indiana, Kansas, Kentucky, Louisiana, Maryland, Mississippi, Montana, Nevada, New York, North Carolina, Ohio, Oklahoma, Oregon, Rhode Island, Tennessee, Virginia, and West Virginia.

#### What types of liability claims against home inspectors are most common?

Here at InspectorPro, the vast majority of GL claims result from:

- 1. Water damage
- 2. Power outage
- 3. Ceiling hole
- 4. Garage door
- 5. Frozen plumbing



- 1. If you receive an email, letter, text, or pleading from a customer, please contact our office. Lauren is generally more accessible than Roy, but feel free to call either of us.
- 2. We will ask that you provide us with the communication you received plus your inspection agreement and report. If there are other communications related to the claim, we will ask for those too.
- 3. After we review your documents, we will schedule a time to talk to you. Calls generally last 15-30 minutes. We will discuss with you your options, which could include working it out on your own, engaging us to respond on your behalf, or tendering the claim to your insurance company. The strategy we discuss will be based on your specific claim, whether litigation or arbitration has already been initiated, and whether your inspection agreement specifies arbitration as the method of dispute resolution.
- 4. Knowledge is power. We want inspectors to know their options so they can the decision that's best for them and their business.
