# From the President:

# **DSPS Education Audit Results**



I recently went to a meeting at the Department of Safety and Professional Services (DSPS) with Kathy Kilgore, our lobbyist from Swandby/Kilgore. At this time the DSPS has not finalized any changes to the state regulations but I will tell you we are working with DSPS to assure any changes will not be detrimental to our organization.

Kathi did share the following results of the

DSPS audit in an email, excerpted below:

Of the 693 licensees audited, 436 were not in compliance (37.1% compliance rate) for the following reasons, in order of prevalence:

- 134 licensees have not obtained 40 hours of continuing education since January 1, 2011. This also includes licensees who submitted an Audit Table without required certificates of completion; with insufficient documentation of course attendance; or submitted documentation for courses that do not relate to home inspection.
- 118 licensees did not complete 20 hours of continuing education in both 2011 and 2012, but did complete a total of 40 hours of

- continuing education in the 2011-12 biennium.
- 81 licensees did not respond to the audit letters at all and/or did not submit any documentation of CE attendance.
- 71 licensees did not complete 20 hours of continuing education in both 2011 and 2012 and did not complete 40 hours of continuing education in 2011-12, but completed continuing education hours in 2013 to apply retroactively to the 2011-12 biennium. These licensees have obtained a total of 40 hours of continuing education since January 1, 2011.
- 31 licensees indicated they wanted to give up their licenses, had retired, or are deceased, and therefore did not complete 20 hours of continuing education in both 2011 and 2012.
- One licensee who received a license in 2012, and therefore was only required to complete 20 hours of continuing education, did not complete 20 hours of continuing education in 2012, but had completed hours in 2011 prior to receiving his license. Therefore, this licensee completed a total of 20 hours of continuing education in 2011-12.

As you can see, the audit results are embarassing to many inspectors. As a professional, I take pride in my licenses. I personally try to obtain a minimum of 40 hours every year. Sometimes the information is redundant but, no matter the subject or venue, I get to talk to other inspectors and learn something new every time. The one thing I know in this business is that if I ever think that I know or have seen everything, I will be wrong.

I just returned from the ASHI conference in Nashville, and learned a great deal. If you've never attended one of these large conferences, I strongly encourage you to do so. At the conference, I ran into several of the vendors who attended our December conference, and it was very interesting to listen to their feedback about WAHI and our educational events.

Almost every vendor I spoke with said the same thing. Over and over I heard that we at WAHI have the best conference, and the best-organized conference, of any they attend annually. They commented about the friendly and collegial atmosphere, the comeraderie between inspectors, the sharing of stories and helpful hints, and our excellent vendor cocktail party and hospitality room party afterwards. I must tell you that makes me proud to be a member and leader of WAHI.

A tour January meeting, Dan Green from Water Source discussed the full range of geothermal system types, how they function, and how to evaluate their condition and operation.




# Mystery Photo



This month, a Milwaukee Chapter inspector sent us this photo of a water heater. The inspector wrote, "I've never seen this type of water heater before. What can you tell me about this type of heater?

Doug Hoerth, WAHI Vice-President replies:
The heater appears to be natural draft direct vent, but the exhaust is sealed at the top, and it vents out through the sidewall of the home. Not to be confused with a power-vented heater, this heater has no fan. The pipe on top is a double-walled pipe. The outer section of the pipe supplies outside air for combustion to the combustion chamber. The inner part of the pipe is the exhaust vent. Sometimes this is flexible metal as well. But note that flue clearances to combustibles still do apply, the flues must be sealed, and obviously the gas line is problematic.

This type of direct vent heater is often used in mobile homes, although the pipe tends to vent straight up through the roof. Also less often in small basements or utility rooms when there is not enough makeup air for combustion, or when the chimney is damaged or not available. The nice thing about this system is that it can be vented through the sidewall and terminate 12" above grade.



Nick Petrie, newsletter editor adds:

I spoke to Larry Budiac of Budiac Plumbing about this water heater. He said this type was more popular in the eighties, before manufacturer-designed power-vent heaters were made. He almost never sees them any more, but he believes they are still allowed under Wisconsin code. As an alternative in the future, the homeowner could add a grate in the basement door or ceiling to provide makeup air for a power-vented water heater.

# Wisconsin Administrative Code SPS 321.29 Masonry Fireplaces (11) Mantel shelves and combustible trim

Woodwork or other combustible materials shall not be placed within 6 inches of the fireplace opening. Combustible materials located within 12 inches of the fireplace opening shall not project perpendicularly more than 1/8 inch for each inch distance from the opening.

# **Chapter Meeting Continuing Education Credits**

By now, all Home Inspector and Associate Members should have received a postcard indicating their continuing education credits earned in 2013 from attendance at monthly WAHI chapter meetings. Please put this postcard in a folder marked Continuing Education Credits 2013. Be prepared! Contact Julie Arnstein *immediately* if your records indicate something different in terms of meeting attendance and earned credit.

Changes are bound to happen at the Department of Safety and Professional Services in Madison as a result of the state audit. WAHI plans to be ready and encourages the membership to do the same.

The Fox Valley WAHI Chapter recently implemented a program using an Attendance Verification Form (AVF). At the chapter meeting, each attendee completes a form with their information as well as the details

of the evening's educational program. At the conclusion of the meeting attendees are given a password, specific to that meeting. This password is intended to verify that the attendee did not leave the meeting early and truly earned the full credit count. The form is in duplicate – one copy to be kept by the attendee and the other for the chapter records. Starting January 2014 all WAHI chapters will make use of this form and implement this procedure.

After January 2014 WAHI will no longer notify members of their year-long chapter meeting attendance credits at the end of each year. Members will be responsible for maintaining their own record of earned Continuing Education Credits with their copy of the Attendance Verification Form. Members are encouraged to have a folder marked Continuing Education Credits 2014 for their AVFs as well as seminar certificates.



# Education House Peer Review and Training Friday March 14, 2014

This on-site inspection event is comprised of 2 parts - an inspection *review* in the morning, followed by inspection *training* in the afternoon. WAHI has obtained the use of a home in the Baraboo area for this program.

#### **Inspection Review**

This inspection review event is an opportunity for you to evaluate and refine your inspection skills with the aid of a panel of your peers, rather than a person with a black robe and a big "hammer" (i.e. gavel). Results will be kept strictly confidential.

The inspections will begin at 8:00 AM. Participants will have two hours to complete their inspection (electrical panels will already be removed, ladders in place, cover off the furnace, etc. to aid in the time limit) Upon completion participants will immediately present their findings and their completed report to the panel as if to a client - the panel of judges have inspected the house and identified defects. Participants are required to bring 2 additional inspection reports (recently completed) for review by the panel to access if they are meeting state standards. There will be "must find, must report" items, previously identified by the review panel, the panel will be looking for (the panel will be focusing on the identification of major defects, not issues such as windows or doors sticking). During the inspection process communication between participants will not be allowed - this event is intended to help participants evaluate their personal skill level. The morning session will be worth 3 continuing education credits and is limited to the first 10 registrants.

### **Inspection Training**

The afternoon session will be inspection training at the same property. Experienced inspectors and contractors will be posted throughout the house in numerous locations to provide approximately 45 minute presentations on how to inspect various components - participants will then rotate to the next area/presenter. The training will take place from 1:00 pm to 5:00 pm and will be worth 4 continuing education credits. The afternoon portion will be limited to the first 40 registrants.

WAHI Member cost to attend this event is as follows:
Educational Review (morning) - \$75.00 Inspection Training (afternoon) - \$60.00
Review <u>and</u> Training (all day) - \$135.00
Non-Members add \$30.00 to the fees stated.

All participants must preregister as space is limited – no on-site registrations.

All participants will be notified by a member of the Education House Committee with the specific location. Lunch (pizza) from 12:00 pm to 1:00 pm for the morning and all day participants.
