We also talked about crawl spaces and how best to evaluate them, and what to look for as far as damage due to lack of a vapor barrier and insulation. Crawl spaces with just a dirt floor can be a cause for mold growth and rot in the wood joists.

Dennis talked about wet basements and solutions. He recommended checking the outside grading, proper installation of gutters and downspouts, and searching for water intrusion spots. His company specializes in crack-filling and he demonstrated the proper procedure for filling cracks. Dennis explained the procedure costs approximately \$450. Sam addressed how to identify issues with water softeners and reverse osmosis systems. Instruction was given on what "bridging" is and the best salt to use/recommend.




# Mystery Photo



**Q. What are the clearance requirements for gas meters and vents?**

*Doug Hoerth, WAHI Vice-President replies:*  
Funny how I get asked this question a lot. Both NFPA 54 and the IFGC call for three feet of clearance from the gas regulator vent to a source of ignition. But what's a source of ignition? A vent of any type is a source of ignition, like an exhaust from a water heater or furnace, a dryer vent or a range hood, or any fireplace flue. To my knowledge, the only exception to this rule is the intake for a furnace. But that may also be subject to the manufacturer's installation requirements.

Electrical components are also sources of ignition. These include outlets and switches, and even an A/C unit's electrical disconnect. Although for some reason the main electrical service meter base is exempt from this rule. Sometimes in the past I have found that the gas company will come and install a gas regulator vent port extension at no charge. But I'm not sure that everyone will be so lucky to receive free services from the utility. In addition, I have been told by two gas companies that only they are allowed to install this pipe extension.

**Q. How do you determine what is causing a masonry chimney to leak?**

A. Great question. Sometimes it is obvious, the flashing is pulling away and the masonry is failing. Many are not so easy. If I am in doubt whether it is the masonry or the flashing/roof, I like to do a water test.

One guy goes on the roof with a hose, the other guy is in the attic or area that is leaking. We soak individual areas for a few minutes at a time to see if we can pinpoint: first the roof, then flashing, then right above the flashing, body of the chimney, and then the crown. This test can pinpoint the leak most of the time. I like it because it is an inexpensive way to try and help determine exactly where the problem is, without guessing and spending the homeowners money wastefully.

**Education House  
Peer Review and Training  
Friday March 14, 2014**

This on-site inspection event is comprised of 2 parts - an inspection *review* in the morning, followed by inspection *training* in the afternoon. WAHI has obtained the use of a home in the Baraboo area for this program.

**Inspection Review**

This inspection review event is an opportunity for you to evaluate and refine your inspection skills with the aid of a panel of your peers, rather than a person with a black robe and a big “hammer” (i.e. gavel). Results will be kept strictly confidential.

The inspections will begin at 8:00 AM. Participants will have two hours to complete their inspection (electrical panels will already be removed, ladders in place, cover off the furnace, etc. to aid in the time limit) Upon completion participants will immediately present their findings and their completed report to the panel as if to a client - the panel of judges have inspected the house and identified defects. Participants are required to bring 2 additional inspection reports (recently completed) for review by the panel to access if they are meeting state standards. There will be “must find, must report” items, previously identified by the review panel, the panel will be looking for (the panel will be focusing on the identification of major defects, not issues such as windows or doors sticking). During the inspection process communication between participants will not be allowed - this event is intended to help participants evaluate their personal skill level. The morning session will be worth 3 continuing education credits and is limited to the first 10 registrants.

**Inspection Training**

The afternoon session will be inspection training at the same property. Experienced inspectors and contractors will be posted throughout the house in numerous locations to provide approximately 45 minute presentations on how to inspect various components - participants will then rotate to the next area/presenter. The training will take place from 1:00 pm to 5:00 pm and will be worth 4 continuing education credits. The afternoon portion will be limited to the first 40 registrants.

Educational Review (morning) - \$75.00    Inspection Training (afternoon) - \$60.00
