From the President:

I thought I would share a few changes in the education tracking system in advance of the seminar. Now that the WI Department of Safety and Professional Services (DSPS) is monitoring CE credits more closely, WAHI felt this hand-written edit may appear unprofessional in the eyes of the State. Sometimes a few individuals have not been present for all of the sessions without having their certificate adjusted, resulting in these individuals receiving more credits than they actually earned. In addition, some attendees would forget to take their certificate and Julie would then have to send the certificate to that individual.

As a result of the issues stated above, the WAHI Board of Directors has decided to use the same credit verification forms used at chapter meetings for the seminars as well. This will prevent any confusion and put the tracking of continuing education credits directly in the attendees' hands. The forms and the necessary speaker information will be provided at the start of each session. Each speaker will provide a password at some point during their presentation. Hopefully this process may eliminate any future issues.






